Introduction

The 2024 Municipal Census was conducted by the City of Fort Saskatchewan's Legislative Services Department.

This summary report provides data collected between April 1, 2024, and June 19, 2024, with the information being collected as of April 1, 2024. The municipal census was conducted to obtain an accurate count of the City's population in accordance with the requirements of the Municipal Census Regulation.

An accurate count benefits the city in several ways:

- It determines the amount of per-capita funding received from the Provincial and Federal Governments.
- It informs planning for the community as it grows and changes.
- It provides information needed for providing health and social services.
- It provides demographic information useful to businesses and community organizations.

The census includes data such as the number of residents in each dwelling unit, the age and gender of residents, as well as responses to the 2024 Aquatics Question.

This report was officially released on September 25, 2024.

Methodology

Data collection for the 2024 Municipal Census began on April 1st through the City's secure online census website. Residents were able to access the City's online census website using a Secure Access Code (SAC) that was hand delivered to every address.

Dwellings that had not responded online prior to April 20th were visited by City enumerators during the door-to-door campaign. Enumerators visited all remaining dwellings, either collecting information at the door or leaving callback cards which allowed residents to either respond via telephone or by scheduling a visit with an enumerator. Dwellings with no response after SAC circulation and the enumerator door-to-door campaign were contacted by members of the City of Fort Saskatchewan Legislative Services Department.

Overall the total response rate for the 2024 Municipal Census was 99.81%. Of the 11,765 total enumerated dwellings, 11,233 (91.7%) were occupied and accounted for a population of 29,857 people in 2024.

Quality Assurance

In accordance with Provincial regulations, respondents were asked to participate in the quality assurance portion of the census by supplying a telephone number; this allows the City to call and once more verify the number of residents in a dwelling. Dwellings contacted for quality assurance were randomly selected. Of the 787 dwellings that provided a callback number, 377 were contacted.

Results

This final report represents the results of the census through various tables and figures. Where possible, census data from previous years is provided for comparison and to identify population trends.

The population numbers within this document are representations of the raw information collected through the census enumeration process – no extrapolation or imputation was performed.

Total Population

The total population of Fort Saskatchewan as of April 1, 2024, was 29, 857 (Table 1), which includes 359 residents of the Fort Saskatchewan Correctional Centre.

Please note that the graphs in this report do not include the 153 residents accounted for though the Municipal Affairs formula for estimates for non-contacted private dwellings and refusals for occupied private dwellings. Because of this, the total population noted in the tables is 29,704.

The City's population has increased by 1,233 residents in 2024 from 2023, which represents an increase of 4.31% (Table 1).

Population by Gender

In 2024, 46.2% of the population identify as female, 46.2% as male, 7.28% are not stated, 0.13% are transgender and 0.19% identify as Non-Binary (Table 2).

Table 3 and Figure 1 demonstrate that the 35-39 age category includes the highest number of residents, followed closely by the 30-34 and the 40-44 age categories.

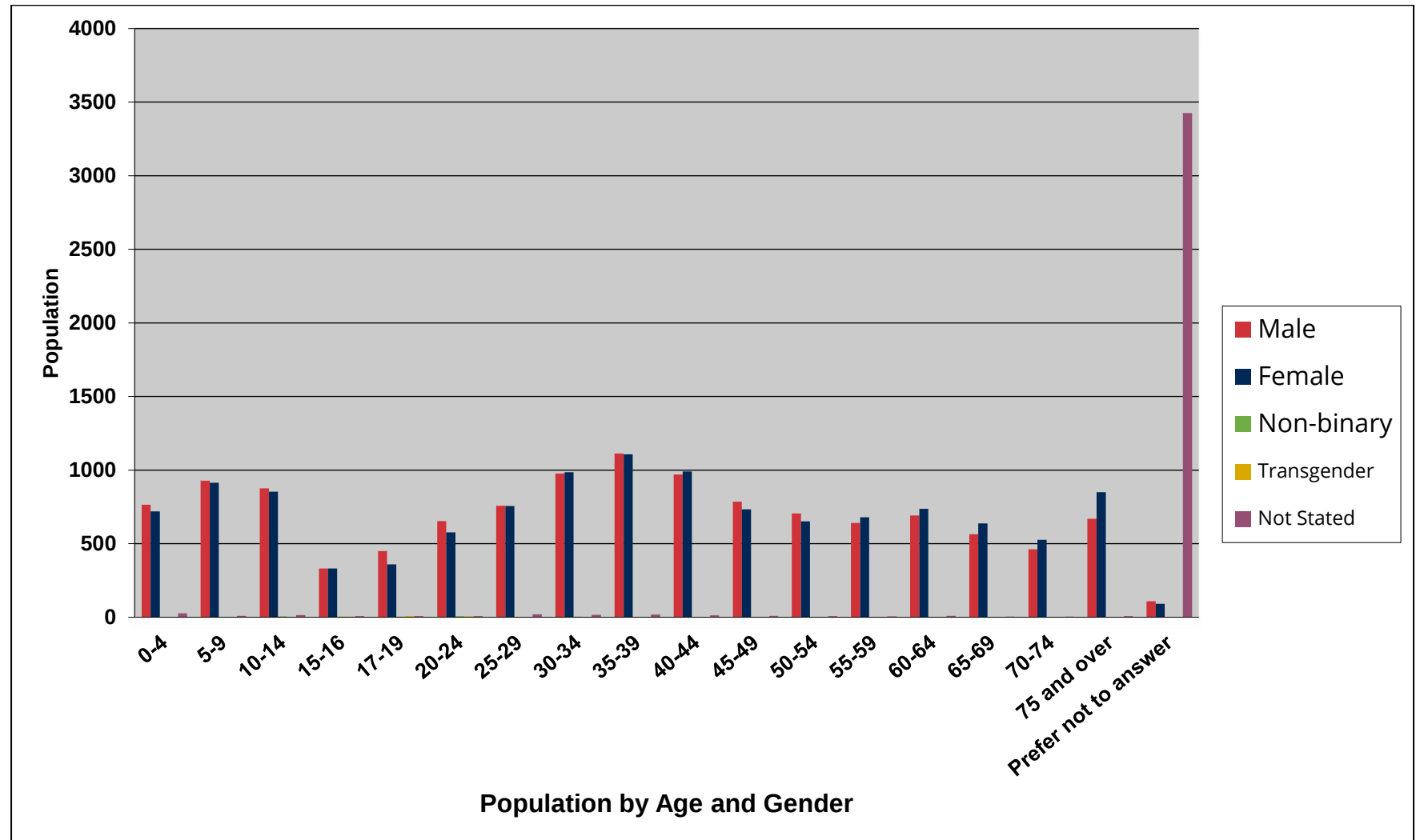

Dwelling Type

Figure 2. Population by Enumeration Area (101-308)

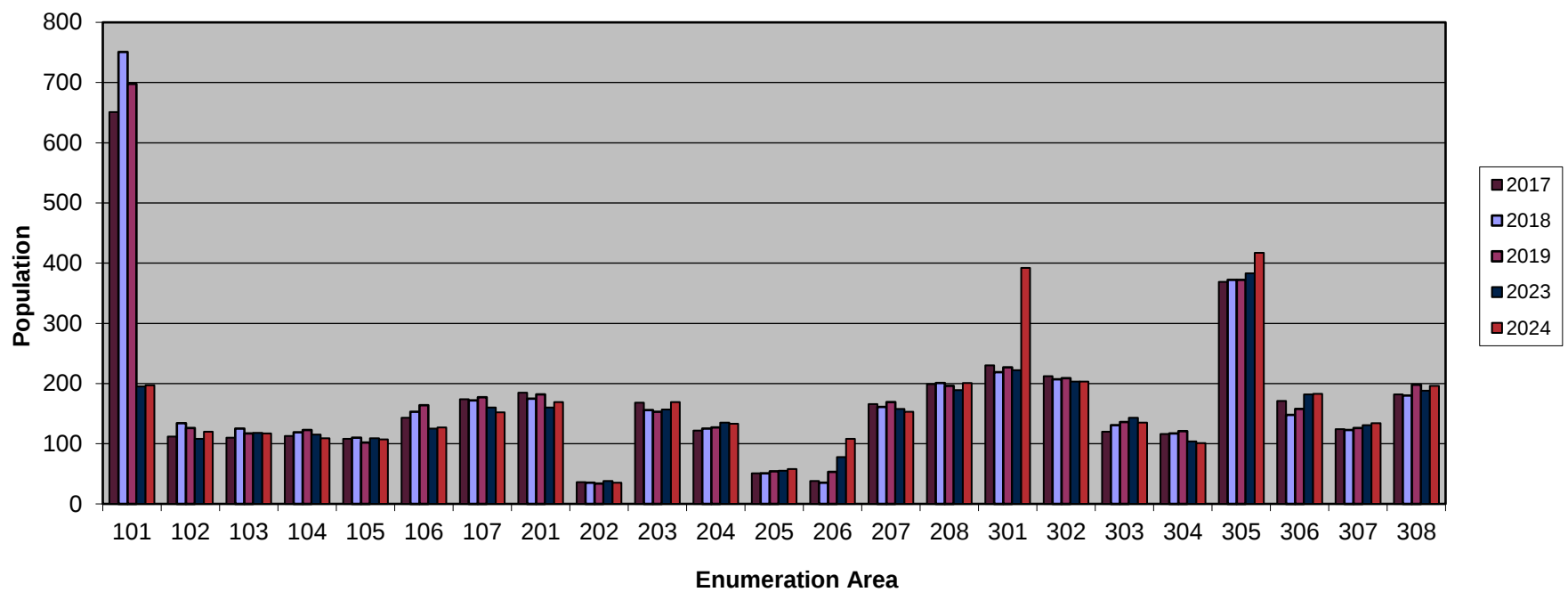


Figure 3. Population by Enumeration Area (309-507)

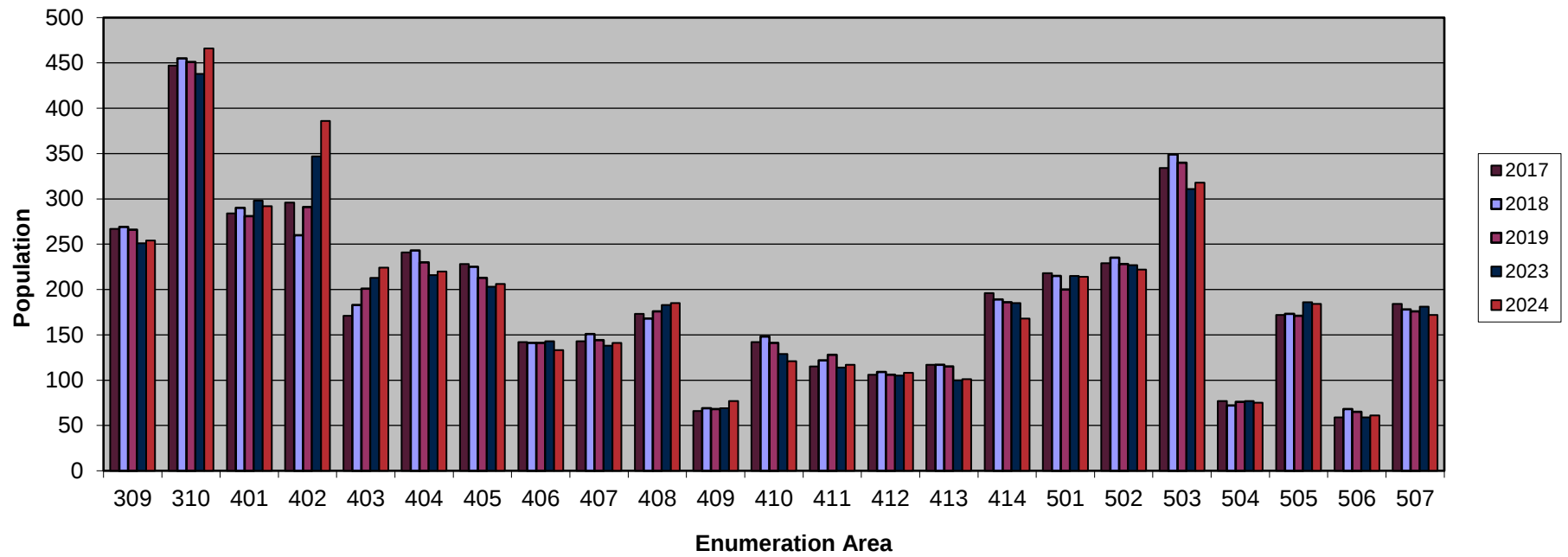


Figure 4. Population by Enumeration Area (508-709)

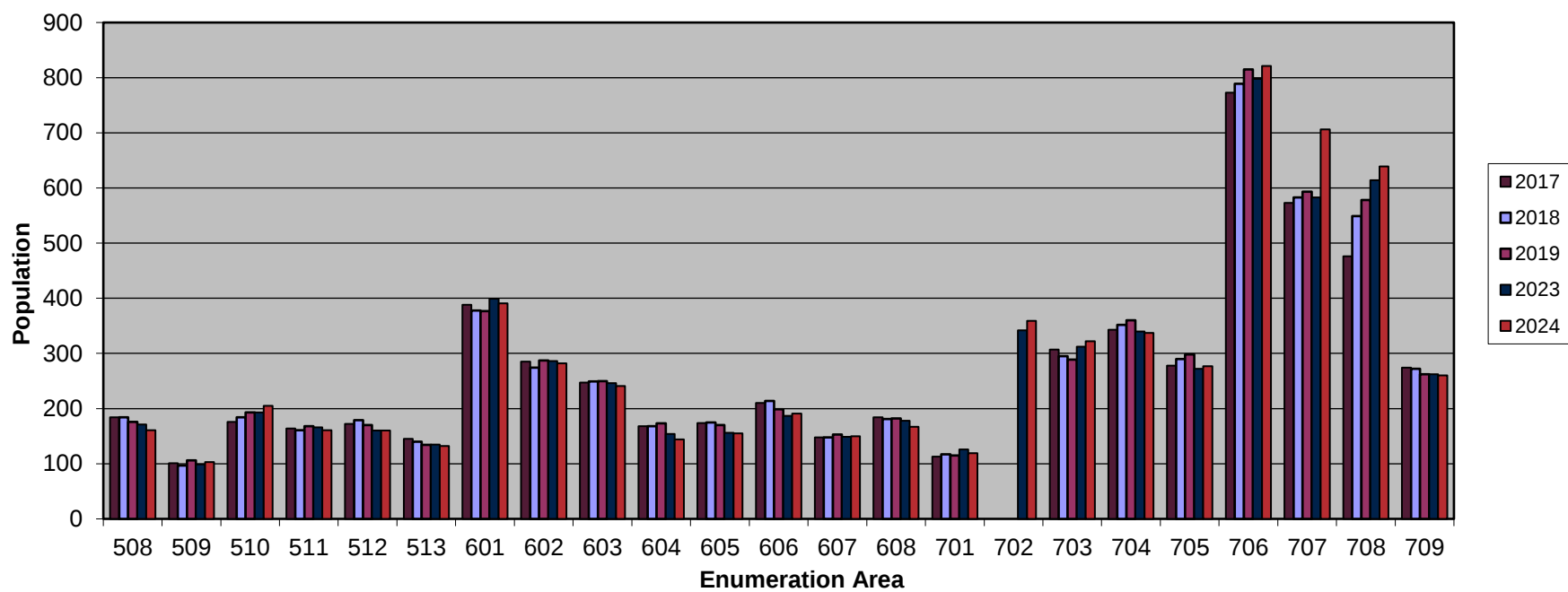
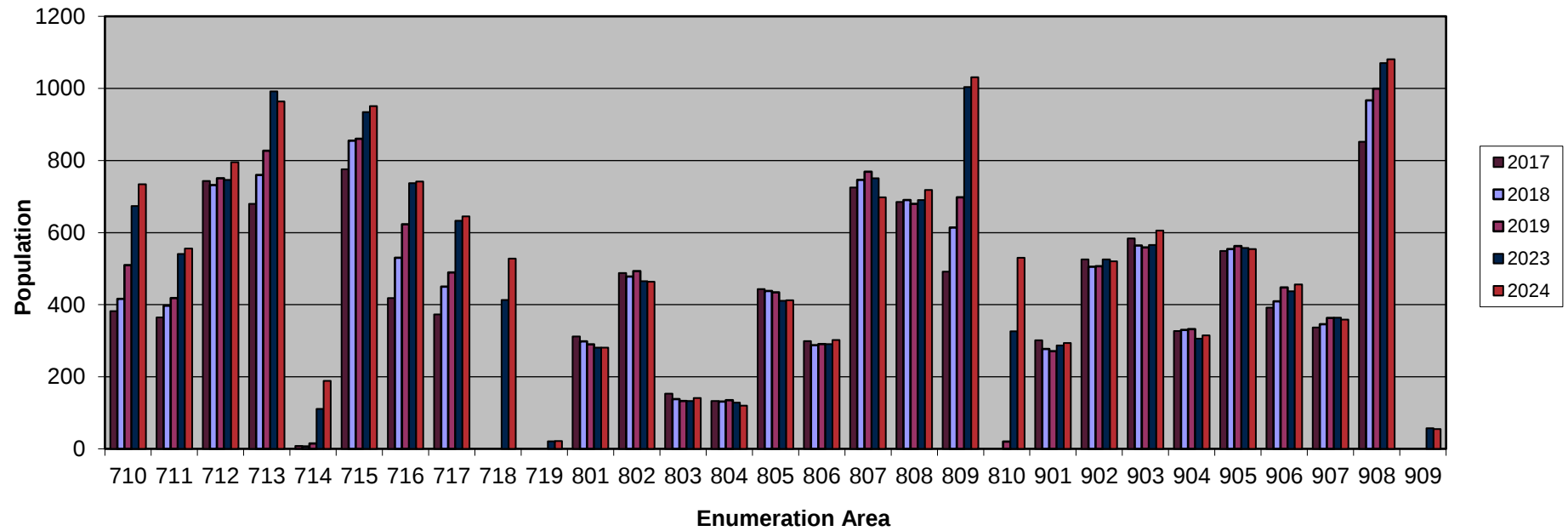


Figure 5. Population by Enumeration Area (710-909)

THE AQUATICS QUESTION

In 2024, Fort Saskatchewan City Council voted to add a question to the 2024 municipal census to gauge public support for building a new aquatics facility at the Dow Centennial Centre, intended to replace the existing Harbour Pool. The results of this question will be reviewed by Council and taken into consideration when deciding the appropriate next steps for the project.

The Question

Below is the question City Council approved for the 2024 municipal census (the “Aquatics Question”), including the provided response options.

"City Council is seeking to gauge public support for building a new aquatics facility at the Dow Centennial Centre to replace the services offered at the Harbour Pool. The new aquatics facility would be approximately 52,000 square feet (more than double the size of Harbour Pool) and would include aquatics amenities such as a separate 8-lane swim tank, leisure tank, tot pool, hot tub, sauna and steam room.

The construction of the new aquatics facility is estimated to cost \$54 million with the debenture expected to be paid over the next 30 years. Based on an average home valued at \$412,925 it could increase property taxes by \$236 per year.

The Results

This final report represents the results of the census Aquatics Question through various tables and figures. The results within this document are representations of the raw information collected through the census enumeration process, and do not include dwellings that were enumerated as “Vacant” or “Under Construction” as they do not house usual residents.

It is important to note the “Prefer not to answer” responses encompass various types of respondents – including those that refused to answer the Aquatics Question, dwellings that were enumerated by landlord or neighbor headcounts, and collective dwelling headcounts.

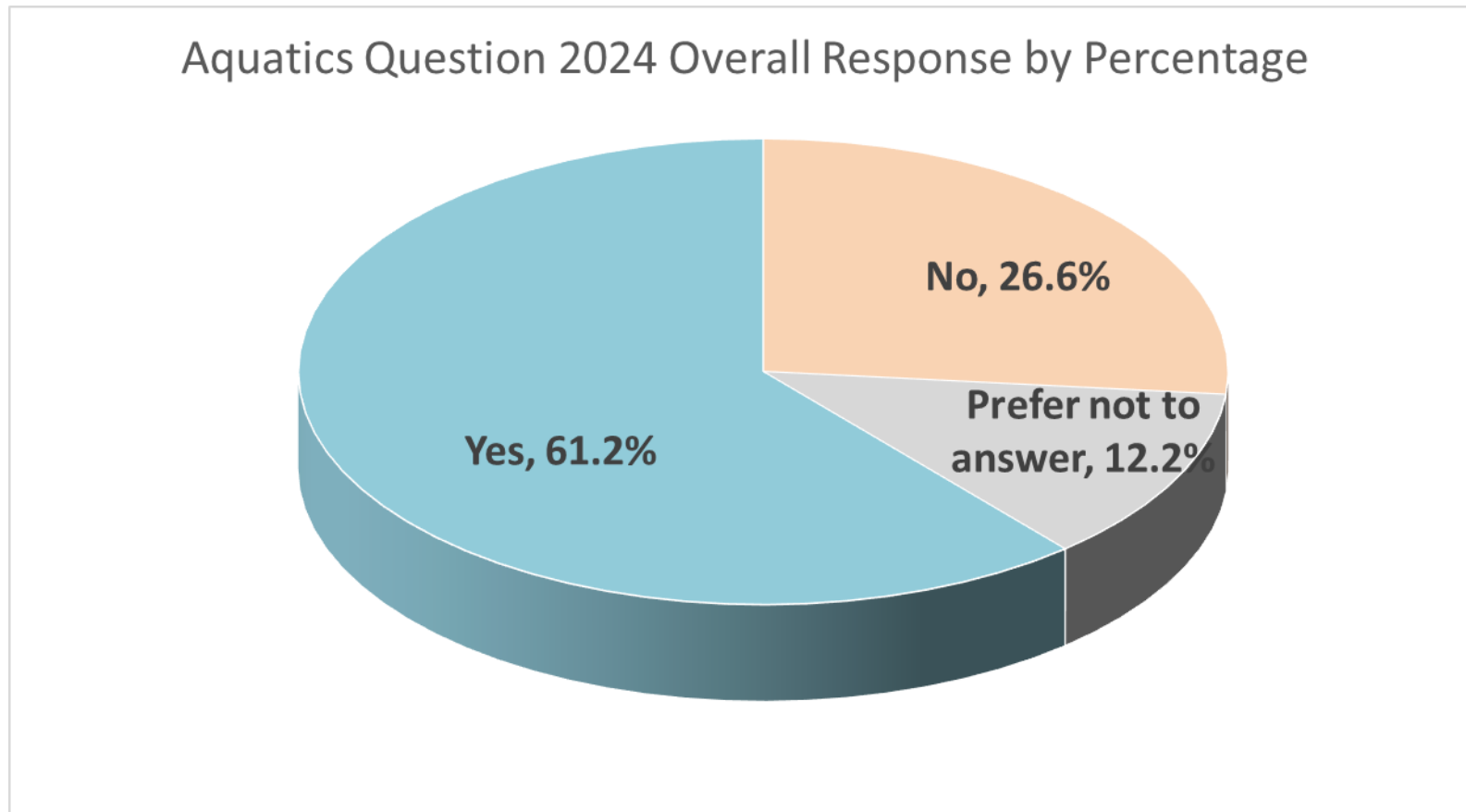
TOTAL OUTCOME

A total of 10,440 households responded to the 2024 census Aquatics Question. Of these respondents, **6,393 (61.2%) voted “Yes”, 2,774 (26.6%) voted “No”, and 1,273 (12.2%) voted “Prefer not to answer.”** Additionally, when excluding “Prefer not to answer” responses, **69.7% voted “Yes” and 30.3% voted “No.”**

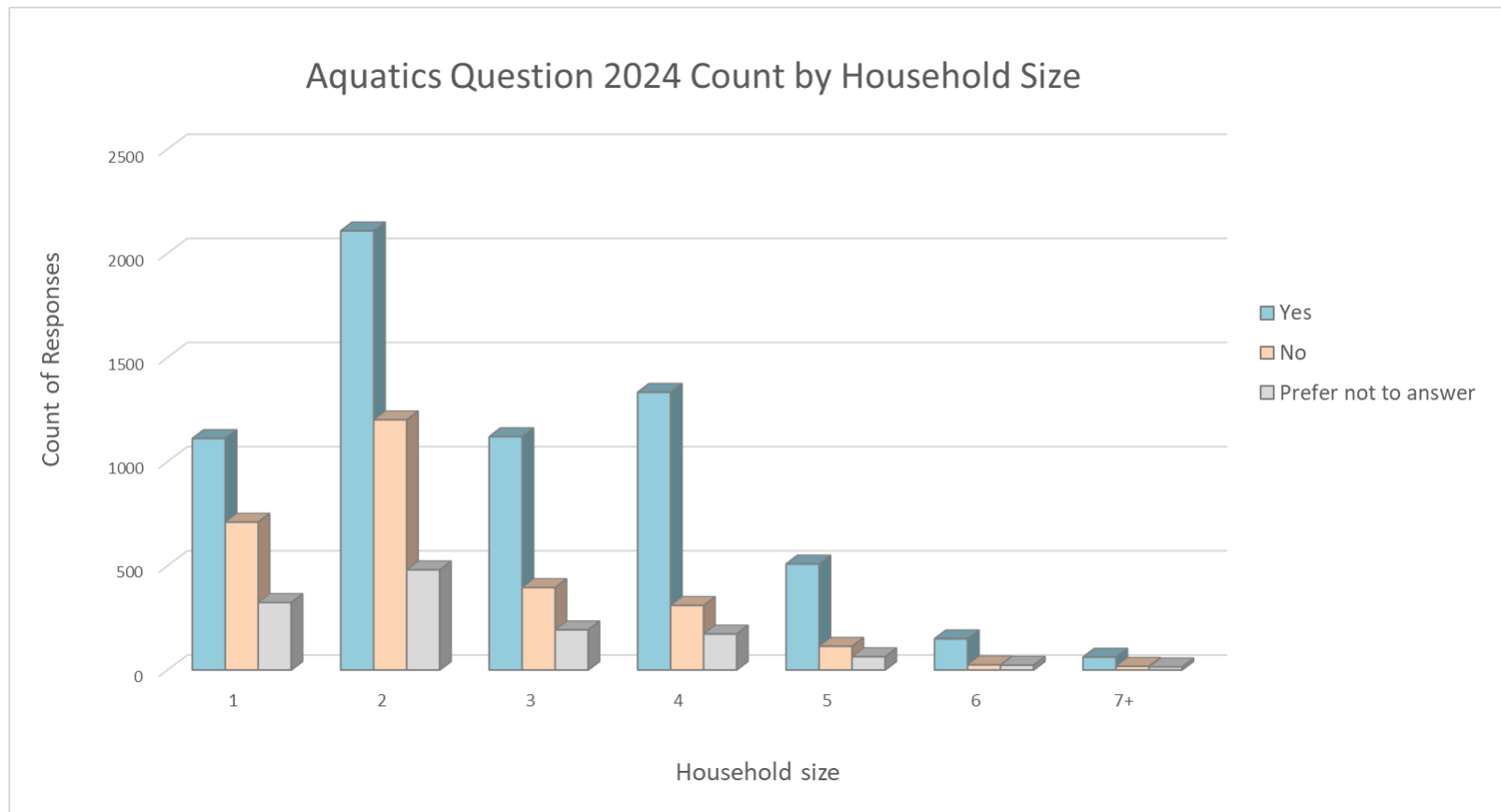
RESULTS BY HOUSEHOLD SIZE

Figure 2. Household Size Aquatics Question Results



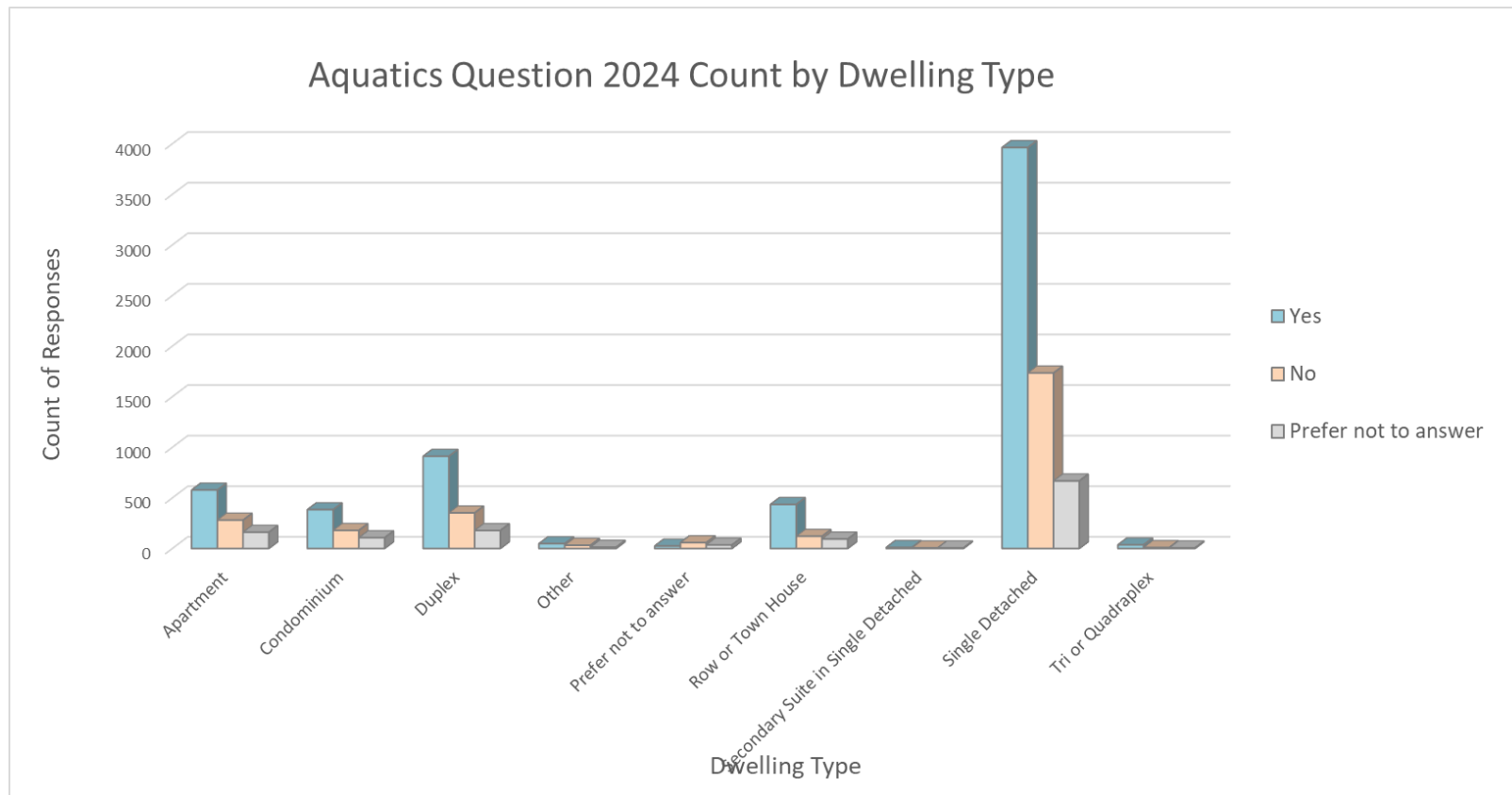
RESULTS BY DWELLING TYPE

The dwelling type that responded “Yes” at the highest rate to the Aquatics Question was **Single Detached dwellings with 3,963 “Yes” responses (62.3%)**, while the dwelling type which responded “No” at the highest rate was **Apartment Dwellings with 281 “No” responses (27.5%)**.

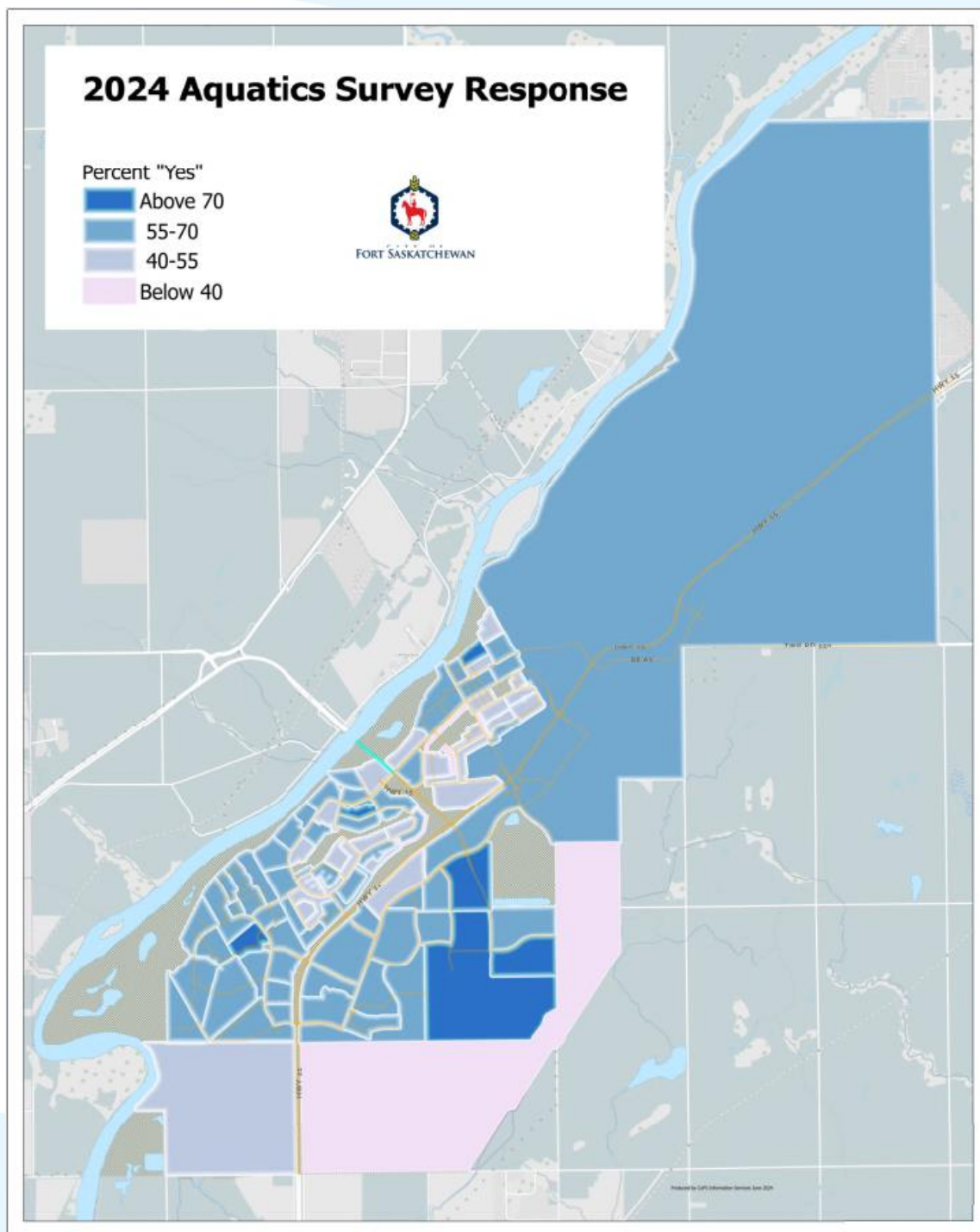


Figure 5. Enumeration Area Aquatics Question Results (EA 101-408)

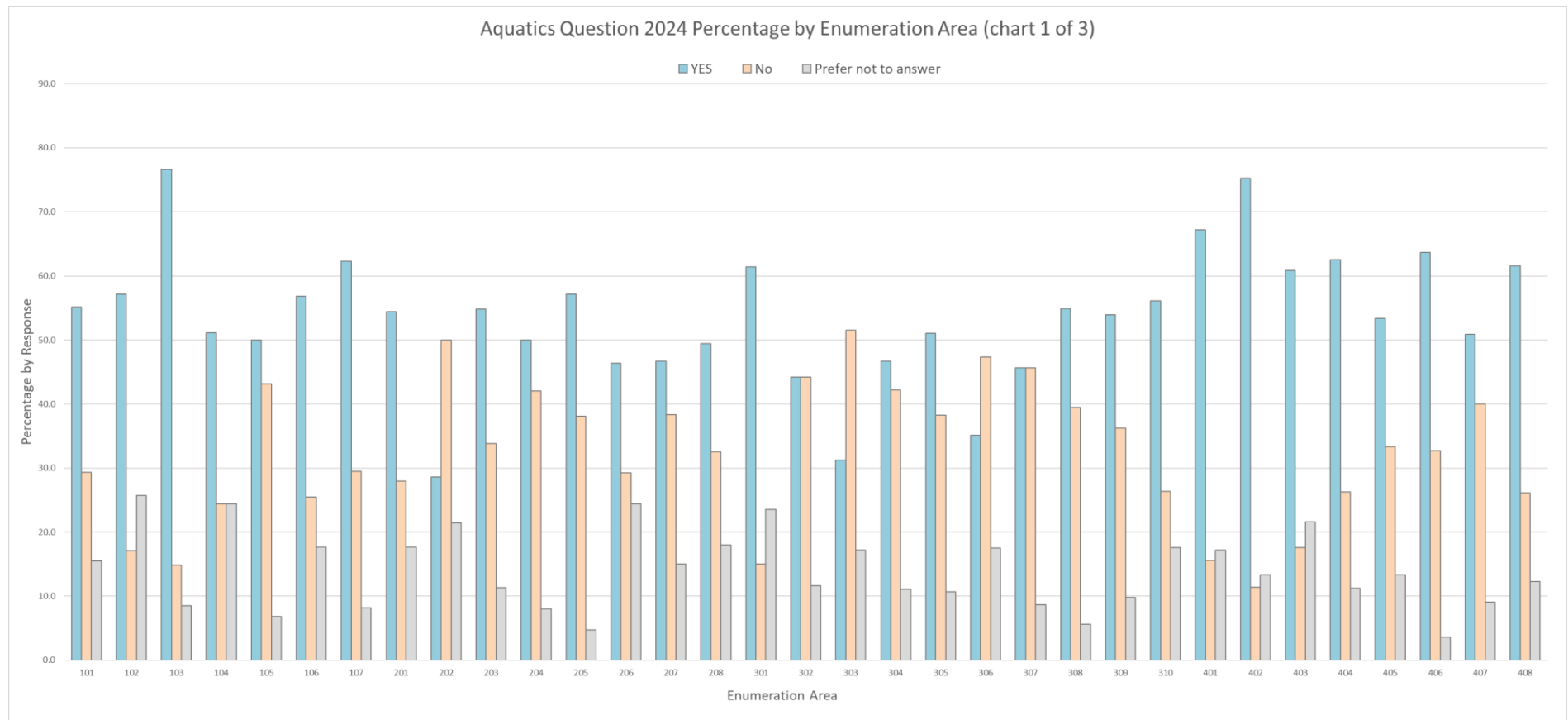


Figure 6. Enumeration Area Aquatics Question Results (EA 409-706)

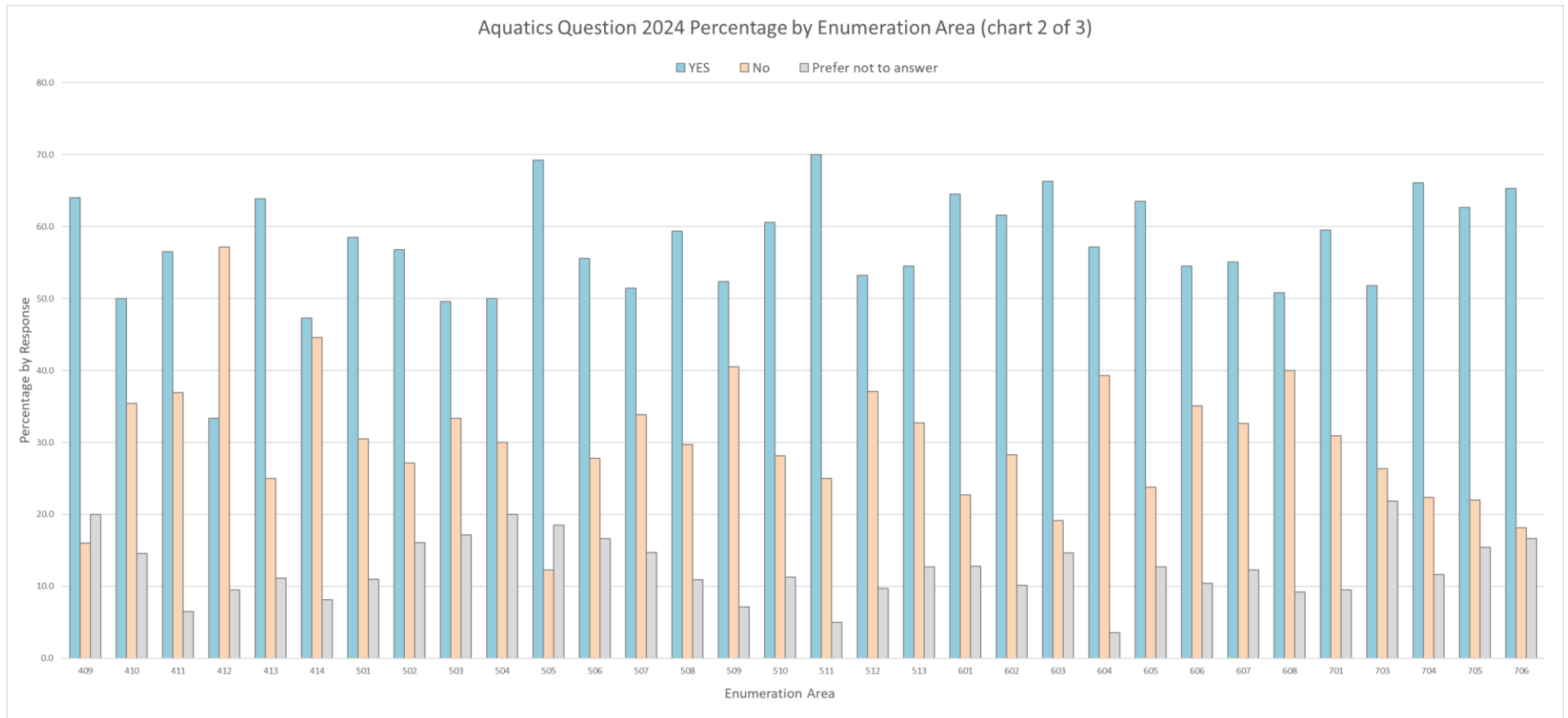


Figure 7. Enumeration Area Aquatics Question Results (EA 707-909)

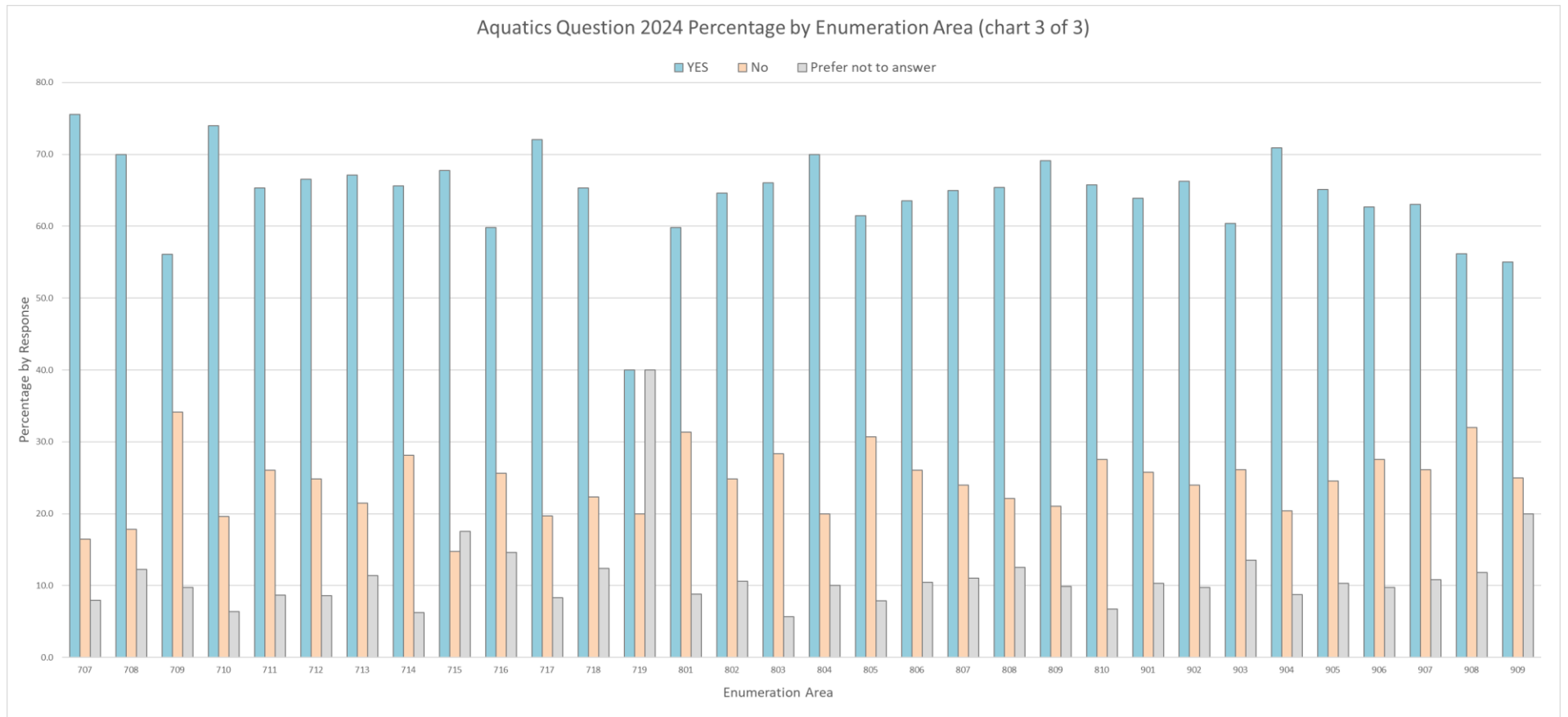
