Consistent with the *Constitution Act, 1982* (Canada), the *Education Act* provides:

1. That a corporation that has shareholders may direct the same portion of their taxes in support of schools to the Protestant separate school division that the value of shares owned by shareholders who are Protestant bears to the total value of all shares of the corporation. A Protestant is defined as an individual who is Christian and does not recognize the Pope as head of the Church.
2. That a corporation that does not have shareholders or a cooperative association may direct the same portion of their taxes in support of schools to the Protestant separate school division that the number of members who are Protestant bears to the total number of members.
3. That a School Support Notice given by a corporation or a cooperative association under Section 148 shall state that the information in the School Support Notice has been approved by a resolution of the shareholders, the members or the directors.
