1. Under the Occupational Health & Safety Act, field location of existing utilities is **MANDATORY**. Failure to obtain same will invalidate this excavation permit. Please contact Alberta One Call at www.albertaonecall.com or 1-800-242-3447.
2. This excavation permit is valid for seven (7) days after expected start date. Invalid if work suspended for more than 48 hours.
3. Contractor is responsible for all traffic control and signage. Public Works must approve signage plan.
4. Re-construction methods must conform to the City of Fort Saskatchewan's Engineering Standards and Specifications.
5. The site must be restored once excavation work is complete.
6. Re-inspection and/or Backfill prior to inspection will result in a fee of \$255.00 per inspection.
7. Camera review fee is an additional \$255.00 per permit.

Further permits may be required to complete this work. The City of Fort Saskatchewan reserves the right to request additional liability insurance that names the City as an additional insured before permit can be approved.

The City of Fort Saskatchewan reserves the right to inspect all sites and to designate corrections to unsatisfactory work. The City of Fort Saskatchewan may rectify unsatisfactory work, the cost of which shall be borne by the applicant. The applicant agrees to indemnify and save harmless the City of Fort Saskatchewan and its employees for any damage of any nature or kind caused to persons or property by reason of this work.
