PURPOSE

This policy establishes a grant funding program to aid in funding school playgrounds.

POLICY

The City of Fort Saskatchewan encourages the use of the natural environment by supporting the development of public spaces through the City of Fort Saskatchewan School Playground Grant Program.

EXECUTIVE LIMITATIONS

1. Requests for funding will only be accepted for playgrounds adjacent to elementary schools, junior high schools, and middle schools and must be a registered non-profit or registered society;
2. The request for funds must be for a playground located within the City of Fort Saskatchewan; and
3. The maximum amount of funds to be allocated is \$25,000 per year, which may be a combination of City of Fort Saskatchewan in-kind donations and grant funding.

AUTHORITY/RESPONSIBILITY TO IMPLEMENT

1. The City Manager will be responsible for implementation and compliance of this program.

PURPOSE

To establish the process for application and approval for the City of Fort Saskatchewan School Playground Grant Program.

PROGRAM INTENT

The program is intended to provide funds to support parent groups who create a not-for-profit societies for the purpose of constructing a new playground or replacing an existing playground, located on a school site within the City of Fort Saskatchewan.

PROCEDURE

1. The organization requesting funding for a playground project must be a registered non-profit society under the Societies Act of Alberta.
2. Only one application per playground project will be accepted.
3. Funding will be awarded on an annual basis to the successful applicant(s). A maximum grant of \$25,000 will be distributed annually to one or more applicants, at the sole discretion of the City of Fort Saskatchewan.
4. The funds awarded may be a combination of in-kind and grant funds not to exceed \$25,000 from the City of Fort Saskatchewan.
5. Prior to receiving funding, applicants must meet with the Infrastructure Management Department to clarify roles and responsibilities with respect to maintenance requirements. Playgrounds that become City property will require design approval by the City.

PROCESS

1. Requests from any group must be in writing on the prescribed application form (Appendix A) and must include justification for the request, as well as a proposed budget and conceptual description of the project.

2. Application forms (Appendix “A”) may be obtained through the City of Fort Saskatchewan website or at City Hall.
3. Applications will be accepted till February 28. If multiple applications are received, they will be reviewed by the Infrastructure Management and Recreation Departments, based on the criteria noted on the application, and the ability to meet the intended purpose of the program.
4. Successful applications will be notified on April 30
5. Funding resets annually on January 1.
6. The Infrastructure Management Department will provide the information to the Finance Department for distribution to the successful applicant(s), ensuring a smooth and efficient movement of funds.
7. At the end of each year, all unallocated City of Fort Saskatchewan Playground Grant Program funds will be held in reserve for future use within this program.
